It is approved in NUC PRO Second Category. NUC meaning ?Pleasure Vessel for Commercial Use?.

This approval follows, in particular, Division 241. This Division 241 is that of pleasure craft intended for commercial use, whose hull length is less than or equal to 24 meters. An NUC (Commercial Use Vessel) approved vessel is a pleasure boat that offers commercial activities, such as passenger boarding, sea fishing, diving, etc. However, due to the limitation of boarding capacities and navigation conditions, the regulations applied differ from those of passenger ships. It follows the rules of pleasure craft, with additional requirements to guarantee the safety and conformity of the equipment on board.

this San Remo 865 has a large cockpit ensuring a good distribution of people when fishing; wide gangways and a large saloon at the front of the cockpit allow very good circulation.

Equipped with livewells, numerous rod holders, ...

The stainless steel T-Top, fully enclosed by a custom-made cover, ensures maximum protection for the pilot of this San Remo 865 T Top.

A small cabin with bedding, sink and marine toilet allows you to spend one or more nights on board.

As for electronics, it is equipped with a SIMRAD 12-inch GPS plotter from 2024, an autopilot, a double VHF e-Com with AIS function.

For its engine, this San Remo 865 T Top is equipped with 2 Suzuki V6 200 horsepower engines, in excellent condition and maintained by a professional Suzuki dealer.

All maintenance invoices are available; the current owner being the sole owner since the origin of the boat.
